Drs. Roberto et al. wrote a review entitled "Posterior partially edentulous jaws, planning rehabilitation with dental implants". In order to treat posterior edentulous jaws well, they in detail summarized several key points including space of restoration, bone quantity and density, radiographic techniques, selection of number, diameter, and length of the implants, and occlusion. This manuscript was well written. Besides the above parameters, these authors might consider differences among aging, gender and race in the future. Several minor questions may need to be changed as follows: On page 2, line 3; the word "literature" may be changed to "literatures". On page 4, line 3, the word "literature" may be changed to "literatures". On page 4, line 9; the word "were" is changed to "was". On page 4, lines 10-11; the words "clinical trial, randomized control trial, review, case report, classical article, comparative studies, controlled clinical trial, evaluation studies, in vitro and in vivo studies, multicenter study, and -----" may be changed from single to pleura, "clinical trials, randomized control trials, reviews, case reports, classical articles, comparative studies, controlled clinical trials, evaluation studies, in vitro and in vivo studies, multicenter studies, and -----." On page 4, line 15; the word "review" may be changed to "the review". On page 6, line 29; the word "aesthetic" needs to be changed to "aesthetics". On page 6, line 33; the word "teeth" may be changed to "tooth". On page 6, line 26, the word "affect" needs to be changed to "affects". On page 6, line 27, the word "determine" needs to be changed to "determines". On page 8, line 2; the words
