Some abbreviations seem to be in Italian (e.g. PCR, likely CRP, and VSG likely ESR) 2. The most interesting part of this manuscript is the extensive literature review. I think this should be highlighted and include the review methodology and outcomes as well as a more thorough explanation of the findings. This would merit a whole paper in itself, i think. 3. COMMENTS TO AUTHORS

This is a well written report, of an interesting syndrome. A few minor clarifications would help improve it, which I think are down to translation issues rather than anything serious. The literature review was done well, is detailed and adds to the case. A clear clinical message is also presented. 1) When talking about BAL the following is said 'negative even crop exam for bacterial and mycobacterial' I think this may just be a translation issue but it doesn't make sense - do you mean the BAL was negative for both bacterial and mycobacterial infection on both Gram stain, culture and cytology? 2) Another minor translation issue in the discussion 'According with some studies, it seems to be a prevalence for male gender, and autumn and winter months present the higher prevalence' I would suggest rephrase to 'According to some studies, male patients are more at risk, and cases are more prevalent in autumn and winter months' In general the first paragraph or two of the discussion appeared to have slightly poorer English than the rest of the report so should be reviewed carefully
