SPECIFIC COMMENTS TO AUTHORS

This is a sound case report but with limited clinical relevance. Even though Bacillus subtilis is a rare cause of cerebral abscess in immunocompetent persons, the case report has no major impact on clinical practice. Besides the issue of relevance there are only

some minor remarks: - The authors should comment on whether they think transthoracic ultrasound is sufficient to rule out endocarditis. - The authors should comment on the duration of the antibiotic regime. - A follow-up of this patient would be interesting to exclude re-occurrence of the abscess after a few weeks (see comment concerning antibiotic therapy). - In my opinion, priority claims ("first report") should be generally avoided; but this depends on the journal's policy. - Article highlights: The authors should provide a real "clinical diagnosis" based on their clinical findings and not just a description. The authors should at least briefly mention additional differential diagnosis based on the imaging findings.

manuscript is to indicate a rare case of spontaneous cerebral abscess caused by *B. subtilis*, evolved in a previously healthy immunocompetent male patient. The presented case is the first in the literature describing the evolution of a cerebral abscess by *B. subtilis*. The new concept proposed by the study is that oral bacteria might transfer to brain and cause diseases there. Overall, the manuscript was well written. However, it's better to present all the results of blood and cytokines as well, besides of the photos.
