More evidence suggestive of the pancreas origin may be necessary, because the pancreatic duct was intact in the MRCP: did the angiogram show whether the tumor was fed by the pancreatic branch?; were the macroscopic findings suggestive of the pancreas origin?; was an immunohistological exam performed to detect elements originating from the pancreas tissue?
