Interesting paper discussing a rare case of kyphoscoliosis in EDS and how to manage it, but some modifications and corrections needs, to consider this work: 1- Some grammatical and spelling errors must be corrected: -Figure 3: Radiographs almostly 6

weeks following cervical operation demonstrates that there is a partial correction of the preoperative kyphotic deformity. -..... 2- The authors has not described enough the radiological findings in the observation: CT scan and MRI 3- Figure 2: the title is not complete. Images of X ray, CT scan, MRI! What the X ray shows? And CT? How about MRI? 4- Figure 2-3-1: must be change because the lines hide the spine! 5- The name of the patient must be erased from the figures 6- Chiropractic care may be of benefit to some patients with connective tissue disorders, (including Ehlers-Danlos syndrome). Is there a place for this treatment? How about reeducation and kinesitherapy? 7- Psychosocial issues, including patient desire to return to work, were important factors in work disability status and perceived outcome. 8- No need for cervical traction before surgery?
