Dear editor and authors, The authors presented a case with chronic patellar tendon rupture condition treated with their new technique by applying the LARS for the tendon reconstruction. They claimed to have favorable outcomes although the follow-up time is short. I have the following comments: 1. Typo and grammatical errors are found throughout the manuscript. For instance, page 4, section of Imaging examinations: The lateral knee...superiory, ...patella;The...; page 5, section of TREATMENT: however, an autograft reconstruction require...; page 6, ...allogeneic 2. Details of how to calculate the preoperative and postoperative Lysholm score should be shown. Adding a table maybe a good choice. 3. In Figure 1a, imaginary lines/labels should be drawn to show how you calculate the Insall-Salvati ratio for clarification.
