SPECIFIC COMMENTS TO AUTHORS

This article discussed the current ethical status of the medical decision-making process and how to use Foucault's philosophy to change unreasonable phenomena in medical decision-making. For lack of sufficient decision-making power for patients, the current ethical model based on universal principles is not being useful to provide a capacity for patient decision-making. Dr Foucault was an outstanding philosopher, who owned a deep understanding of the historical development of medicine and hospital. In this article, the author explains current status and potential modification methods with Foucault's philosophy, which shows Dr Foucault's deep understanding of medical history and in-depth thinking about medical progress. Honestly, this is the first detailed overview of Foucault's philosophy in the patient's medical decision-making. This manuscript has important reference value for medical professionals, including doctors, nurses, and clinical drug developers. The author used Foucault's philosophy to accurately outline the current development of medical decision-making, and at the same time uses Foucault's philosophy to put forward what medical decision-making should be in the future. In fact, both Eastern and Western philosophies could be applied to medical decision-making, because medical decision-making must ultimately consider the maximization of benefits for the patient or the entire society.
