This is an interesting case report regarding multiple gastrointestinal hemangiomas. The topic is promising and the use of polidocanol has clearly increased in recent years. The whole paper (especially the abstract) should be edited for english-language usage. The aim of the study should be better explained in the introduction. Furthermore, a brief introduction on the uses of polydocanol in the control of bleeding should be added: Short-Term Results of Sclerotherapy with 3% Polidocanol Foam for Symptomatic Second- and Third-Degree Hemorrhoidal Disease. However, there are some points to clarify: - The whole paper (and not just the abstract) should be edited for english-language usage. Indeed, there are numerous grammatical errors and linguistic inaccuracies. Especially in the introduction. - The authors reported the ref. 7 in the text as "Pierluigi". Unfortunately it is not correct. The best way is "According to Lobascio et al." or other ways. Therefore it is necessary to modify both the sentence and to change from name (Pierluigi) to surname (Lobascio)
