It is a little difficult to differentiate from the air containing mediastinal lesion because only one non-contrast enhanced image. Would you like to add the images for further evaluation? Please add further image good quality of images. 2. In the contents of section of introduction and discussion, upper gastrointestinal massive accumulation “of blood” would be better to insert in the sentences. 3. In the conclusions, how about inserting the additional reference as I described below. ‘Peritonitis with small bowel perforation caused by a fish bone in a healthy patient. Yonghoon Choi et al. World J Gastroenterol. Feb 14, 2014; 20(6): 1626–1629.’ 4. Would be better to insert the ‘s’ to the sentence of “Fig.3 Removal of a massive blood clots from the stomach”.
