This is an interesting case about the main trunk of superior mesenteric vein resection without reconstruction during surgery for giant pancreatic mucinous cystadenoma. The authors presented the case of a 58-year-old woman with a giant pancreatic mucinous cystadenoma adhering the SMV, underwent an en bloc tumor resection, including the main trunk of SMV and the spleen. And this case indicated that the main trunk of SMV might be resected without venous reconstruction if adequate development of collateralization may already present. 1 There are minor language polishing need to be corrected. 2 Referecnes can be updated. 3 Figures are good.
