What is the position of the Author about MT and in general about phytoterapy for this disease? - Please revise mistakes (i.e. double spaces and similar) in the text. UGI was first reported in the text in the introduction section, but the acronym is not reported.

COMMENTS TO AUTHORS

The article is very interesting and the described problem is very important. However, there are many new review articles dealing with the same subject which were published recently, even in WJG, e.g., Kim MS et al. Optimal management for alcoholic liver disease. Figure 4: Approach to management of alcoholic hepatitis – there is no explanation about the pentoxifylline treatment arm. “Continue steroids” – should be stated – like in the text – that GKS should be continued for 21 days and then tapered within 2 weeks. There several sentences written too long. Fig. 3 – have the authors permission for the figure publication? I suggest some corrections of nomenclature: e.g., hepatocellular cancer should be hepatocellular carcinoma, deranged renal
