The paper by dr. Koektuerk et al. is a nice review on the relationship between diabetes and heart rhythm disorders. The paper is interesting and well written. The following points are for manuscript improvement. 1.Since the pathophysiology of atrial fibrillation in diabetes is complex, it might be useful to have a figure showing the different factors that in the diabetic patient may play a role in its arrhythmogenesis 2.There are some typographic errors throughout the manuscript that authors should eliminate. For example: on page 4 "In a study Acar et al. published..." or on page 6 "%8-10". 3.A paragraph of conclusion is needed
