SPECIFIC COMMENTS TO AUTHORS

Dear Authors, I read with great interest your case report regarding a splenic rupture following a POEM procedure. The manuscript is well laid out and comprehensible. Please find my comments below: 1) In all the other reported cases of splenic rupture following an upper endoscopy that you cited, abdominal symptoms and diaphoresis occurred soon after/immediately after the procedure. Providing a clear cause-effect relationship between the endoscopic “push” and the splenic injury. In the case that you managed and reported, symptoms occurred 3 days after the procedure. Do you have a possible explanation to this “latency” in the onset of symptoms (which likely corresponds to the onset of the bleeding of the spleen)? (the patient did not follow a considerate diet/ portal hypertension due to 2) Prior surgery may contribute to the predisposition to bleeding after a POEM procedure. However, this patient is a chronic consumer of alcohol and may be predisposed to bleeding in case of chronic liver disease. I suggest providing information about the past medical history of the patient. Most important, providing data regarding his potential liver disease.

Authors described a case report of splenic rupture following an endoscopic esophageal myotomy. This is a rare complication after POEM procedure. Case report is well written with adequate background and references on the related topic. Please do the minor revisions as suggested below. 1) please check the grammar once again. 2) In the case description expand the acronyms CT, MRI, CO2. (we should expand it when used for the first time) 3) Mention whether CT scan was done with or without contrast in case description ? 4) Mention normal hemoglobin level in brackets in case description. 5) Rephrase this sentence in discussion. "However, no case of hemorrhage was reported outside the esophagus or stomach[2]. Furthermore, to the best of our knowledge, no case of splenic injury is, reported in the literature till now". 6) Rephrase the sentence in discussion. "In both these cases, the patients seem to have undergone short-time, easy exams with no technical factor explaining the splenic injury".
