Manuscript: Increased frequency of angina attacks caused by switching brand-name vasodilator to generic vasodilator in patients with vasospastic angina: two case reports
The authors report two cases of VSA with an increase in the frequency of angina attacks because of switching from a brand-name to a generic CCB. In both cases, angina recurred upon switching from a brand-name CCB to a generic CCB during the follow-up. The condition improved upon switching back to the original CCB. This is a straightforward manuscript dealing with a topic of interest, the efficacy of generic drugs. The authors have properly addressed the limitations of the manuscript: They did not obtained any ST-T changes on ECG at chest symptoms and also did not perform another coronary angiography and spasm provocation test to confirm the effect of brand-new or generic coronary vasodilators. Chest symptoms were only assessed from self-assessment.
