COMMENTS TO AUTHORS

This is generally a good paper. The main issue is that the authors have not specified what makes their Case Study unique or different to other reports of this injury in the literature. This is important as I currently cannot see what original contribution this paper makes to the literature. There are also many minor grammatical errors which need to be fixed before the paper can be considered for publication. Specific comments are listed below. 1. Line 33: The word ‘care’ should be ‘case’. 2. Line 38: Please change this to ‘47-year-old’ i.e. include dashes. 3. Line 56: Can the authors please provide a brief explanation of the QuickDASH score for readers who are not familiar with it? 4. Line 75: Please change ‘Inappropriate views’ to ‘The type of views imaged or quality...’ 5. Line 79: Do the authors mean CT shows better anatomical detail than radiographs? Please specify more clearly here. 6. Line 80: Please reword this sentence to ‘Potential injuries to the CMC joint should be carefully investigated in patients...’ or similar. 7. Discussion Section: In the Introduction, line 35, the authors have mentioned that the Bennett’s fracture with a fracture of the trapezium and CMC joint disruption, while a rare injury, has been previously discussed in the literature. Therefore, what are the new

Line 123: 'Bennett's' is spelt incorrectly in the figure caption. 9. Throughout the whole paper: There are many minor grammatical errors. In particular, English articles such as the word 'the' is missing in many places, and the authors need to fix this before the paper can be considered for publication.
