We have read reviewer(s)' comments very carefully and really appreciate your consideration. Our manuscript has been revised according to the comments of the reviewer(s) and revised segments are underlined. Regarding the issues you proposed, we are replying as follows:

Reviewer #1:

Specific Comments to Authors: This is an interesting case of brachial nerve palsy related to hematoma in a hemophiliac patient. The case is informative but will need modifications. Firstly, the abstract need not be structured and divided into several sections. Rather, a short paragraph for the abstract should be sufficient. Similarly, case presentation is divided into several headings like Hx of present illness and past medical Hx etc. The case presentation should be in a flow and in the form of few paragraphs only. Please try to modify it. Also, elaborate on the physical exam findings to describe the nerve areas involved rather than just saying e.g medial forearm was involved. Under surgical description you have referred to the lesion as "tumor" while referring to it as a mass or lesion will be more appropriate.

1. The results of the physical examination were described in details according to the neural areas involved (see Page 5).
2. **"The mass"** was used to replace "the tumor" (see Page 6).

Reviewer #2:

Specific Comments to Authors: The author presented a patient with hemophilia and hematoma related brachial plexus compressive neuropathy. However, the lesion noted in figure 2A was yellowish tissue instead of hematoma-like appearance. The author should explain the surgical finding and showed the histopathological picture.

3. The surgical management of this patient was performed 2 months after the onset of symptoms. Therefore, the excised lesion was an organized chronic hematoma instead of a fresh one. **The gross finding of the resected specimen was added in**

the figure 3 (see Figure 3c).

4. The **histopathological feature of the resected mass** was shown in the **figure 2**.

Science editor's comments

1. The case statement should be incoherent and the structure of the article should be reorganized. 2. The results of the physical examination need to be detailed to describe the neural area involved. 3. The abstract is not concise and complete enough to point out the theme and innovation points of the article, and needs to be rewritten.
