## FOR Reviewer #1:

Q1. The manuiscript is too narrative and basic information lack (e.g. renal function, liver biochemistry, etc). Therefore, it could be benefited by an informative table regarding all clinical and laboratory findings during the disease course.

A: We added the renal function (BUN, Cr) and liver biochemistry (AST) to the table 1.

Q2. How was the referred bilateral pneumonia treated?

A: We treated the bilateral pneumonia with meropenem, linezolid, voriconazole, aminophylline intravenous infusion, and terbutaline aerosol inhalation. (page4, line 114; page 5, line 135).

Q3. Minor issues - Please amend "motality" for "mortality" (end of first paragraph)

Q4. Please clarify the meaning of the phrase "The bone marrow aspiration test indicated after one month of CAR-T treatment".

A: The bone marrow aspiration test indicated after one month of CAR-T treatment revealed completely remission.(page5, line 141).

## FOR Reviewer #2:

Q1. The conclusion must be added.

A: A conclusion has been added at the end of this manuscript (page 7; line 198)

Q2. The relevant cases must be compared. The discussion must be expanded.

A: This is the first case of CRS complicated with rhabdomyolysis after CAR-T therapy in our center, and haven't found any case report like this patient during our review of the literature. We compared the relevant cases which CRS complicated with rhabdomyolysis caused by infection, especially COVID-19. Meanwhile, we added some new treatment methods of rhabdomyolysis to

the conclusion part (page 6, line 184-190). We will continue to pay attention to these similar cases and underlying mechanism.

Q1. The title of the manuscript is too long and must be shortened to meet the requirement of the journal (Title: The title should be no more than 18 words).

A: We shorten the title length and spelled out the abbreviation: Cytokine release syndrome complicated with rhabdomyolysis after chimeric antigen receptor T-cell therapy: case report and literature review

Q2. Authors are required to provide standard three-line tables, that is, only the top line, bottom line, and column line are displayed, while other table lines are hidden. The contents of each cell in the table should conform to the editing specifications, and the lines of each row or column of the table should be aligned. Do not use carriage returns or spaces to replace lines or vertical lines and do not segment cell content.
