I have marked few short coming in the manuscript which has been marked in the returned file. The grammar needs further polishing. The authors are requested to report on the reported incidence on pheochromocytoma-induced atypical Takotsubo cardiomyopathy. A small comment on how the patient was prepare for surgery. Also, what type of procedure was done(open versus laparoscopic vs robotic). what precaution and measures were taken operatively. comment on histopathological features of specimen. post-op medication. How frequently patient was followed. on each follow up what investigations were done.

2. We have added to the epidemiological status of the disease, written in line 167-169 of the manuscript.
3. We have added to the patient's preparation for surgery and type of surgery, written in line 129-132 of the manuscript.
4. After the patient was admitted to the hospital, we took effective preventive measures and treated symptomatically to prevent and control the patient's recurrence of malignant hypertension, myocardial infarction and other adverse events, and performed surgery with the application of doxazosin, written in line 125-132 of the manuscript.
5. Regarding the histopathological characteristics of the specimens, we describe them in the Legend section of Figure 4, and the diagnosis was written in line 219-225 of the manuscript.
6. We added the postoperative medications, the patient was doing well postoperatively without any significant discomfort, and only lipid-lowering therapy was administered. Also, we followed her up after 1 year and the patient did not have similar symptoms again, and her ECG and echocardiogram were normal, but unfortunately, no imaging data were collected at the time of follow-up. These were written in line 134-139 of the manuscript.

syndromes: a case report and literature review could be an interesting case to report, as you alluded in this article. The most parts of the manuscript have an acceptable spelling, grammar and syntax. However, before it becomes publishable, it still requires some improvement. Here are my comments: 1.The abstract must be included of background, case summary, and conclusion. You must arrange them by this maxim. 2.There are no keywords in your manuscript. For determining the correct and most appropriate keywords, you can use Medical Subject Headings (MeSH) or Google Keyword Planner. 3.You did not allude Core Tip in your manuscript. 4.The introduction is very short. The constructs and concepts in the introduction section are poor-organized and incomplete. Include more general and specific background in this section. 5.If there are any kinds of Laboratory examinations, you must mention them in table format with precise figures. 6.The case presentation must be included of Chief complaints, History of past illness, Physical examination, etc. You can download one of the accepted articles in the journal and see the format. 7.Most bibliographic citations which been used are more than 5 years old and obsolete. The authors must update and arrange the bibliography. Important note: the manuscript has not been written with journal's standards.
