1. The comment: English is uniformly poor. It should be edited by a professional English editing agency and a certificate should be provided.

4. The comment: In case summary, the follow-up is 27 months, whereas in the main report it is mentioned as 9 months. Please reconcile these figures.

5. The comment: Figures in text should be in sequential order, e.g., Figure 1A, 1B, etc. and should not start with 1B.
