
- 1 Format has been updated to fit with stated guidelines

- 2 Revision has been made according to the suggestions of the reviewer
  - (1) Reviewer 2753135:
    - The indication for such extensive surgery in a metastatic (lung) setting can be questioned. Were there liver mets?
      - Response- No.
    - Although neo-adjuvant therapy was planned, this was not administered because of "disability" and "bleeding." The authors should give more details on the circumstances of why this adjuvant therapy was not given. What is meant by bleeding?
      - Response- More details were added on page 3 under Case Report, paragraph 1, lines 6-11.
    - Post operatively adjuvant chemo-radiation was planned. Patient developed a large recurrence early in the post op period (<3/12). Was patient actually given adjuvant therapy within the 3/12 period or was this delayed by wound healing?
      - Response- Treatment was delayed at outside facility secondary to patient compliance. Please see additional detail under Case Report, paragraph page 4, paragraph 4 lines 6-7.
    - Are there post op pictures?
      - Response- No.
  - (2) Reviewer 2508408: no suggested changes, we thank the reviewer for their positive comments.
  - (3) Reviewer 289416: no suggested changes, we thank the reviewer for their positive comments.

- 4 Provided first page of following reference since it is not indexed in PubMed.
