Review of reviewer 1: This is a high-qualified article which has various benefit for the reader. After the control and correction of grammatical rules, it may be accepted

Answering of Reviewer 1. We are re-sending our article after the controlling and correcting the grammatical mistakes. Corrections are given as below.

a.Summary section: TAVR abbreviation was corrected in line 1 of page 2 as below.

TEE abbreviation was corrected in line 11 of page 2 as below.

Corrected sentence: Transcatheter aortic valve replacement (TAVR) is recommended in patients with severe aortic stenosis and who have high surgical risk.

Sentence before correction: **TAVR** is recommended in patients with severe aortic stenosis and who have high surgical risk.

Corrected sentence: The mitral prosthesis was functioning normally and mild-moderate paravalvular leakage was evident by transesophageal echocardiography (TEE).

Sentence before correction: The mitral prosthesis was functioning normally and mild-moderate paravalvular leakage was evident by **TEE**.

b. Introduction section: The sentence in line 4 of page 3 was corrected as below.

Corrected sentence: However TAVR has been performed off-label to treat patients with pure aortic regurgitation due to the absence of annular or leaflet calcification for device anchoring.

Sentence before correction: However TAVR has been performed off-label to treat patients with pure aortic regurgitation due to the absence of **calcium** for device anchoring.

c. Case section: The sentence in line 22, 24 and 25 of page 3 was corrected as below.

Corrected sentences: By arteriography mild aortic regurgitation was demonstrated (line 22). He recovered without any complication (line 24). At one month follow up, the patient was well and his New York Heart Association Class was 1 and 2 (line 25).

Sentence before correction: By arteriography mild aortic regurgitation was demonstrated (line 22). He recovered without **complications** (line 24). At one month follow up, the patient **is** well and **now in** New York Heart Association Class **1 and 2** (line 25).

d. Discussion section: The sentence in line 16 of page 4 was corrected as below.

Corrected sentence: However, preprocedural screening of the patient by multislice tomography and interprocedural transesophageal echocardiography are essential for the safe procedure.

Sentence before correction: However, preprocedural screening of the patient by multislice tomography and interprocedural transesophageal echocardiography are essential for the safe **prosedure**.
