We describe the case of a **nonsmoking** 46-year-old man with PLCH diagnosed based on clinical manifestations of fever and dry cough, with a history of hypothyroidism and diabetes insipidus for 9 years.

4.In page 2 (case presentation section) the authors state that on CT there are "adenocarcinoma nodules". Do they mean that this was a presumptive radiological diagnosis? If yes please rephrase:

To prevent ambiguity we changed the description of CT:A chest CT examination was performed before his hospital visit, and multiple nodules with blurred borders were detected in both lungs.

5. In page 7 the authors state that lung diffusion function was normal, which is rather odd. It would be interesting to make a comment in the discussion session e.g lung parenchymatic disease was diagnosed on an early stage??

Pulmonary function findings indicated normal lung diffusion function. Considering that the consolidation of both lungs was located near the hilar region, the area of

alveolar involvement was small, and there was no interstitial change in either lung, with little effect on diffusion function.

6.Please check that the units in Table 1 meet the SI units requirements. Maybe the normal values for the hormones should also be provided. Names of abbreviated words should be provided on the table as well:

The units in the table were changed to international units as required, and the normal values of hormone levels were marked. The abbreviations involved in the text were marked at the end of the text.

7.It would be nice and interesting to add some information regarding the therapeutic intervention to this patient

The disease involved a low-grade malignant tumor. Symptomatic treatment was initiated, and follow-up by the Hematology Department was required for further treatment of the pulmonary Langerhans cell histiocytosis. At follow-up, the patient did not receive further treatment, and his condition had not progressed.

8. The whole manuscript needs thorough revision in terms of language preparation because some phrases are incomprehensible, e.g In the conclusion session the phrase "has no effect on anti-infection" makes no sense to me.
