Reviewer #1: Scientific Quality: Grade B (Very good) Language Quality: Grade B (Minor language polishing) Conclusion: Minor revision Specific Comments to Authors: Dear Authors, I reviewed your manuscript. You may find as follows my main comments/suggestions:

**R1** 1. No conclusions are included in the abstract section. This section must be briefly described the implications of the study, followed by recommendations for future studies

## A: We add a conclusion in the abstract

**R1** 2. In the "limitations of the study" section, I suggest the authors to add some brief consideration on other potential risk factors of occupational burnout (e.g., grief caused by multiple losses, personal characteristics, and limited supportive resources to handle workload) during the COVID-19 pandemic with appropriate references (see doi: 10.1177/20101058211040575).

A: We agree with this suggestion and we added considerations and reference on other potential risk factors of burnout in the limitation paragraph.

**R1** 3. Please review the manuscript for use of acronyms. For this purpose, define the acronyms separately in the abstract and introduction before using them in other sections of the manuscript. For example "the coronavirus disease 2019 (COVID-19)" or "HCWs."

**R1** 4. Finally, I suggest that the manuscript is proofread by a native English speaker or Editing service. So please make sure there are no English errors.1) Overall, English language must be fundamentally improved as there are spelling and grammatical errors throughout the manuscript, e.g. "28.9% patients", "had more longer hospitalizations", "we did not observed differences", "we did not found an association" etc., which make the manuscript hard to read and understand.
