Regarding 2nd comments: There are few reports concerned with effects combined with these agents for eradication therapy (clinical trial). However, according to reviewer, I summarized the matter with combined effect on anti-*H. pylori* activity in clinical study in Table 2.

Regarding 3rd comments: I am sure that there are many guidelines for *H. pylori* treatment in individual countries. The regimens and protocols of these guidelines are not always the same among countries. In this reviewed article, I summarized the natural products with anti-*H. pylori* activities and showed the possibility that these effective components may be available for protection of *H. pylori* infection and *H. pylori* treatment. From now, thus, we need to evaluate *in vivo* effects using such components (in particular, clinical investigation) to make an adequate guideline for the application on *H. pylori* treatment.
