  - a. We removed the unclear citation (page 3, paragraph 1 of the manuscript and the references section).
  - b. We corrected "Peutz-Jeghers" to "Peutz-Jeghers Syndrome" (page 3, paragraph 2 of the manuscript).
  - c. We rephrased the unclear statement "as well as an increased number of high-grade PanIN lesions compared to low-grade" (page 13, paragraph 3 of the manuscript).
  - d. We corrected " $\geq$  FDR" to " $\geq 3$  FDR" (page 15, paragraph 6 of the manuscript).
  - e. We corrected "a FDR" to "an FDR" (page 15, paragraph 6 of the manuscript).

  - e. We added a table of other factors associated with PDAC (Table 2, page 33 of the manuscript).
