Responses to the peer-reviewer (Reviewer code: 2541688)

(1) Comment 1: This study had several inevitable limitations as authors said in articles, for example, some obvious heterogeneity, bias and unpublished data or only abstracts.

Answer: We agree with the comment that there are several limitations in our study. The major limitation is the heterogeneity, especially in the meta-analysis of quadruple therapy. So we performed subgroup analyses and sensitivity analyses to find the reasons of heterogeneity. We performed sensitivity analyses when our unpublished data were included in the meta-analysis of quadruple therapy and the results showed that the impact was little. Additionally, we described the conclusion cautiously and carefully to avoid misleading.

(2) Comment 2: It would be better if the study added cost-benefit analysis of various regimens for eradication of *H. pylori*.

Answer: We fully assent the reviewer's comment, but there is hardly any study supplying the data about cost-benefit analysis among the studies included in our systemic review. So it is difficult to perform the cost-benefit analysis of different regimens for *H. pylori* eradication.


