A Supplementary table including their complex, Myc-independent functions would not fit to the central aim of the review, that is why we would avoid to insert such a table. Please, accept our explanation.

2. Figure 1 has been revised, now it illustrates the main control of c-Myc expression and biological effects of the gene product as well.

3. The hypothetic therapeutic applications of c-Myc in inflammatory colonic disorders has also been summarized in the revised Table 1.

4. In Table 1. the classification of therapeutic pathways is performed by the main pathobiochemical effects of the different drugs. In the text, the discussion of the potential drugs are listed by their main chemical structure (direct inhibitors, biologicals, miRNAs, etc.). that is why the order of different drugs are altered in Table 1. as compared to the manuscript. We believe that the classification of these drugs according to both their chemical sturcture and their main effects are equally important for the readers.
