Thank you. Novel and updated information on Gluten-free diet compliance has been provided. Emerging therapies have been addressed in the past in *World Journal of Gastrointestinal Pharmacology and Therapeutics* by this author.

Thank you. Agree with all reviewer points and added to manuscript (marked in yellow) as follows:

1. Agree. Emphasis in introduction as "...but a balanced gluten-free diet...and certified manufactured gluten-free foods...".
2. Agree. Specialist dietitian was noted under heading of Gluten-free Diet Treatment.
3. Agree. Sentences added: "...In addition, referral to a specialist dietitian...but nutritionally adequate (...added sugars and total fat)..." and "...As sensitivity to gluten...in different individuals with celiac disease...".
4. Agree as noted at end of section on Gluten-free Diet Treatment: "...Finally, some have indicated that labeling as "gluten-free" may be problematic, especially for commercial products that may contain small or trace amounts of gluten, and are not strictly gluten-free...".
5. Agree. See added statement at end of section on Serological Assessment of Compliance as "...clearly needed to define sensitivity, ... that may modify the amount of fecal peptides".
