

1. PLEASE CHECK STATISTICAL FIGURES IN THE ABSTRACT AS WELL AS THE MANUSCRIPT AS THERE IS DISCORDANCE BETWEEN THE TWO

The error has been corrected in the abstract: “This significantly affects patient outcome: the only cure is surgical resection but only up to 20% of patients present with resectable disease at the time of clinical presentation.”

2. THE MANUSCRIPT REQUIRES REVISION OF MINOR GRAMMATICAL ERRORS

We have corrected grammatical errors found in the manuscript.

3. AT MANY PLACES THROUGH THE MANUSCRIPT, “PANCREATIC CANCER” AND “PDAC” TERMS HAVE BEEN USED INTERCHANGEABLY. THE TWO TERMS MEAN 2 DIFFERENT DIAGNOSES, AND THE MANUSCRIPT SHOULD BE REVISED TO REMOVE THESE INCONSISTENCIES.

We have acknowledged that the term “pancreatic cancer” encompasses multiple pathologies in the manuscript.

We have ensured that the terms used are concordant with those used by the authors of the studies being reviewed and have clarified the comparison groups of the studies where possible.
