## **2 Peer-review report**

Reviewer #1: This is a scoping review suggesting that liver involvement by the SARS-CoV-2 infection is associated with a high rate of morbidity and mortality. The article is well-written and relevant. It can be published; however, I have two minor issues that need to be addressed:

1. Please provide the search strategy for study selection.

**Response:** Literature searches and screening strategies were used to identify literature. This strategy consisted of a broad search of the online scientific database on the PubMed webpage using the most common synonyms to identify all potentially relevant studies. In subsequent steps, references were screened to exclude papers that were not pertinent, and the remaining references were sorted into categories for further evaluation. This point was clarified in the introduction section. Please see the text highlighted in yellow on page 4.

2. Please remove "figure 1" in your conclusion. Please reference the figures in the main text and not in the conclusion.

**Response:** We agree with the reviewer's comment. The reference of the figure is now in the main text. Please see page 7.

Reviewer #2: The author emphasized the current pathways regarded as contributing to the gastrointestinal and hepatic ailments linked to COVID-19 infected patients due to an imbalanced interaction among the liver, systemic inflammation, disrupted coagulation, and the lung. Albeit, the author provides insight into COVID-19 related field, I still have some suggestions.

1, All figures are highly professional, and the authors should guide the readers to the meaning of the images appropriately; otherwise, it is likely to cause misunderstandings. Therefore, I suggest that the author consider revising the figure legends again.

**Response:** We thank the reviewer's observation. As suggested by the reviewer, the figure legend was improved. Please, see page 21-22 in the revised version of the manuscript.

2, In Fig 1, the author discussed the mechanisms of pathological injury upon SARS-CoV-2 infection. It would be fascinating to discuss the correlation between cancer and coronaviruses, such as SARS, or MERS...etc. (PMID: 32416633, 32615317, 32345594, 35639708, 33918958).

**Response:** As suggested by the reviewer, a paragraph discussing SARS-CoV-2 infection and hepatocellular carcinoma was added in the revised version of the manuscript. Please, see page 10-11 in the revised version of the manuscript.

3, There are few typo issues for the authors to pay attention. Please unify the writing of scientific terms. "Italic, capital" ? make it consistent throughout the whole manuscript. For example, Page 4, ...and 31 out of 45 post-mortem liver tissues contained the SARS-CoV-2 "RNA geome[25]". Please correct "RNA geome" as "RNA genome".
