In my view, the impact of your manuscript should significantly benefit by condensing the text by about 50%. Alternatively, you may consider presenting your data in two separate manuscript.

Thank you for your meticulous review of our manuscript. The decision to utilize serum as the biological matrix for assessing IL-6 and LHPP levels was based on several considerations. Firstly, ulcerative colitis (UC) is a chronic intestinal condition characterized by inflammation and ulceration. By interrogating the single-cell landscape of UC-affected colonic tissues, we identified sustained upregulation of inflammatory response pathways during the progression of UC and characterized the features of damaged endothelial cells in colitis (Figures 1F & G). Concurrently, we observed a progressive increase in the proportion of endothelial cells within the colon microenvironment (Figures 1F & G). This phenomenon underscored the significant role of angiogenesis in the ulcerative colitis's progression. A robust vascular network can facilitate the intravasation and extravasation of inflammation factors, enabling metastasis to distant sites within the body (Figures 3C to G).

Additionally, serum samples are not only relatively easily accessible, which enhances their practicality for biomarker analysis in both clinical and research settings, but they also offer a comprehensive reflection of the organism's overall physiological state. Moreover, the use of serum allows for non-invasive or minimally invasive sample collection, facilitating longitudinal studies and greatly enhancing the translational potential of our findings. We trust that the rationale for selecting serum as the matrix for our IL-6 and LHPP assessments is in accordance with the scientific objectives of our study.
