Therefore, we did not exclude these comments from the text but only transferred these statements in the Introduction (1st paragraph) and presented all possible mental disorders additionally in the figure.

Reviewer #2: Manuscript ID: 82310 Title: Diabetes mellitus type 2 as an underlying, comorbid or consequent state of mental disorders This mini-review fully summarizes and analyzes the causal relationship between type 2 diabetes and mental disorders, which provides a good research direction for type 2 diabetes and its concomitants with mental disorders. At the same time, it provides a new therapeutic strategy for the treatment of type 2 diabetes and the prognosis of patients, which is crucial for improving the quality of life of patients with type 2 diabetes. I think there is an issue in this mini-review that the author needs to improve. In this mini-review involving type 1 diabetes, type 2 diabetes and gestational diabetes, as well as a new concept of diabetes, "Type 3 diabetes", in the form of a table, the author should summarize and analyze the bidirectional association between the four types of diabetes and mental disorders, and the possible predisposition factors between them, possible treatment strategies, possible effects on the patient, etc. Through such summary, readers can better understand the relationship between diabetes and mental disorders at a glance, improve the quality of the manuscript, increase the readability of the manuscript, and make it easier to persuade readers.

Answer:

Considering that the first reviewer suggested a narrow approach regarding T2DM correlation and mental disorders, and that the second reviewer wanted a broader approach and correlation, we tried to accomplish a balanced final presentation in the manuscript and only focused on T2DM. Hence, we commented on different types of

diabetes and mental disorders in the Introduction and incorporated all specific parts regarding T2DM and mental disorders in the figure.
