Specific Comments to Authors: In this manuscript, the authors review the engineering nanotheranostic strategies for liver cancer, including gene therapies and photo-assisted therapies. Overall, this manuscript covers a wide range of nanotheranostic for cancer therapy. The manuscript needs to be improved in writing as follows: Point 1: The authors can summarize more gene delivery vectors in the Gene delivery carrier construction part. Point 2: The conclusions section is inadequate and in fact lack of a critical overview of pitfalls and caveats of different types of treatment modalities. Point 3: For the high quality of the journal, a highest quality of images and schemes is of great importance. Of note, the labels in Figure 5 and Figure 8 are incorrect and should be revised.

Reply: We are grateful for your constructive suggestion. Firstly, we have introduced more vectors in the gene delivery carrier construction section. Secondly, the critical overview of this frontier was included in the conclusion section of the revised manuscript. Thirdly, the Figure 5 and Figure 8 were revised according to the reviewer's comments. We thank the reviewer for pointing these, and all points were revised.

The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e., those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
