2. *“As you have mentioned seroconversion in two opposite directions in your manuscript, I think it is appropriate to define the seroconversion after reactivation in the related paragraph in section of results”.*

Reply: We have followed your recommendation and the definition of seroconversion is now added in the revised version (please see page 9).

3. *“In section of discussion, the paragraph starting with: Male sex.....in HBsAg (+) cancer patients, should be corrected to HBsAg(-)”.*

Reply: We corrected this mistake. Thank you.

Reviewer #2:


“Need details on how this study was done retrospective? How were they found? Is there a denominator needs to be organized”
