The report is well written but the content is quite banal. The literature search and the discussion are lazy. The report should be expanded in order to provide lasting utility to readers.

Reviewer 3 Comments

This is an interesting study on the documentation of skeletal variation in 4 divergent species of elasmobranchs with high-resolution 3rd generation DSCT. But I am still not clear what the advantage is of using the dual source CT in the study. The authors also did not explain clearly the reason of not using a Micro-CT, although it may provide significantly more detailed resolution of elasmobranch anatomical structures as the authors said.

Response: Thank you for your kind comments. This study did not include Micro-CT images because with the species were too large for the limited field-of-view of a Micro-CT. This limitation has been added to the manuscript.
