The paper is good written but does not contain anything new.

Answer:

Dear Reviewer, thank you for your comment.

The use of HRCT in EVAR planning or follow-up is not recommended yet, but in the Authors opinion, HRCT examination should be included in CT vascular protocol examination, to early diagnose lung cancers in high risk patients, overcoming the concept of dose radiation induced neoplasms, especially in over 65 years old patients. Recently, some works about dose radiation induced neoplasms, depict CT examinations for vascular planning or follow-up as the main cause of tumor development, so we aim to demonstrate that a CT low-dose "screening" protocol in high risk patients, increases the possibility of early detection of lung cancer.
