Reviewer #1: Scientific Quality: Grade C (Good) Language Quality: Grade A (Priority publishing) Conclusion: Accept (General priority)

Specific Comments to Authors: This is a practical retrospective multicenter cohort study. At a time when medical resources are relatively scarce, a resource re-allocation to help serve the COVID-19 patients might be possible without reducing the level of care for injury-related paediatric patients. However, in my opinion, is it possible to provide some medical advices that the guardian needs to pay attention to to reduce the occurrence of injury?

Answer: We agree have added the following paragraph in the revised discussion:

"The significant drop in incidence of pediatric injuries during the COVID-19 pandemic may indicates that safety priority issues and the development of prevention strategies may be needed. Guardians may help children to adhere to safety recommendations at play grounds, such as a maximum of one child per trampoline. However, most pediatric musculoskeletal injuries are minor and not complicated. The impact of COVID-19 on children and young people's mental health and well-being has been reported to weigh heavily.[19] The disruption to routines, education, recreation, as well as concern for family income and health, is leaving many young people with significant consequences due to the lock down. Furthermore, the lock down has been reported to significant decrease the level of children's physical activity.[20] Regular physical activity is well-known to improve cardiorespiratory fitness, build strong bones and muscles, control weight, reduce symptoms of depression, and reduce the risk of developing serious health conditions.[21]"

Specific Comments To Authors: Please add Figure Legend in your manuscript. The author has carried out multi center big data analysis, and the author has done a good job. I think the author's conclusion is more like the result, without his own views and analysis. Scientific Quality:Grade C (Good) Language Quality:Grade A (Priority publishing) Recommendation:Conditional acceptance. ANSWER: We agree, the conclusion should in our opinion be ultrashort. The main finding of our study are the stated incidence rates. A subjective interpretation would blur these main findings and hamper the likelihood of citations.
