SPECIFIC COMMENTS TO AUTHORS:

This is a retrospective clinical study. Although the number of cases is not large, it shows that PAH should be given NEUi orally if combined with left ventricular dysfunction. We know that PAH has international guidelines, but the references are not cited. I suggest that the latest guideline should be cited and the authors clarify the relationship between the results of this article and the statement in the guideline in the discussion.

Reply: accordingly to the Reviewers' suggestions, the latest version of PH international Guidelines has been cited in the section 'Methods' [lines 126-127 of the revised manuscript], as well as in the section 'References' [lines 297-307 and 361-363 of the revised manuscript]. Furthermore, following Your suggestions, a dedicated paragraph clarifying the relationship between the results of the analysis presented in this article, and the current statement in the international guidelines, has been introduced in the section 'Discussion' [lines 189-194 of the revised manuscript].

Language quality: *Grade B: Minor language polishing.*

Reply: Language quality of the manuscript has been revised and improved.
