Specific Comments to Authors: This highly timely and interesting Mini Review "Binge-eating and psychostimulant addiction" by M. Carmen Blanco-Gandía and co-authors summarizes the current status of the relationship between the disorders of binge-eating and substance use disorder. The overall content and their presentation are of good quality.

My main concerns have to do with the English expression and Grammar. The authors must get this Review edited by a Native English speaking Editor to rectify:

1.Unusual expressions and Grammar

First, we would like to thank the reviewer for the comments and suggestions. Regarding the English expressions and grammar, the entire manuscript has been edited again by a native English-speaking copy editor.

2. Excessive use of abbreviations that must be fully expanded in order to avoid improve READABILITY of this review.

Following the reviewer's suggestion, we have thoroughly expanded several abbreviations to improve readability and hope that the manuscript is now easier to read.

1 Scientific quality: The manuscript describes a Minireview of the Binge-eating and psychostimulant addiction. The topic is within the scope of the WJP. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The overall content and their presentation are of good quality. **The language need to be polished.** The questions raised by the reviewers should be answered; (3) Format: **There is no table or figure;** (4) References: A total of 105 references are cited, including 5 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference. 2 Language evaluation: Classification: Grade B. The manuscript is reviewed by a native English speaker. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Generalitat Valenciana, Conselleria Educacion, Direcccion General de Universidades, Ministerio de Sanidad, Servicios Sociales e Igualdad. Delegación del Gobierno para el Plan Nacional Sobre Drogas and Instituto de Salud Carlos III, Red de Trastornos Adictivos. The topic has not previously been published in the WJP. 5 Issues raised: **For PMID and DOI numbers of references from English-language journals, please ensure there is a space between the PMID and DOI numbers in the square brackets.** 6 Recommendation: Conditional acceptance.
