-we have carefully revised the manuscript further, to streamline and simplify the message. Multiple additional physicians reviewed the paper to make sure the Body of the Article was well revised and without errors. Additionally, we edited the paper further to fit the formatting requirement of WJT.

Reviewer #4 (00503243): *“This is a good manuscript affording the issue of personalized immunosuppression versus one size fits for all. The manuscript covers all the key point of the issue including side effects and de novo antibodies. I suggest to further update the reference in particular for new drugs as Zeus trial (we have now data at five years and reference 35 should be updated) and belatacept. The authors should discuss which is the position of such drugs in the field of personalization. Only some minor polishing for English is needed”*

-the manuscript has been updated with several references (Ref 38, 59, 60 and 61)

-the potential of belatacept has been discussed (Ref 59, 60 and 61)

-as discussed in the response to reviewer #3, the paper also significantly revised for both English and flow of thinking in the paper. We hope the revised paper now reads well.

We look forward for the upcoming peer review of the paper and hoping to contribute to the academic growth and ongoing success of WJT.
