I appreciate the comments and the suggestions

-specific changes to policy and practice have been suggested in the review, such as strict cooperation ICU-OPO in the management of the donors and culturally-sensitive approach to donor families, and others.

-the source of Figure 1 has been indicated in the legend of the figure, and the permission requested.

-Figure 2 and 2 and the Tables (1-2-3) may not be strictly necessary as the Reviewer suggested. However, I would argue in favor of including the above figures and tables to allow the busy clinician to grasp quickly the “core” content of the review as an alternative to reading the review in its entirety. In addition, tables and figures are quite helpful for trainees or “novices” in the field, who are likely more frequent readers of review articles than the seasoned specialist.

The phrase “donor instability and death before organ recovery has been modified accordingly to “donor instability and death during organ recovery”.

While I acknowledge that some paragraphs may be repetitive or redundant, I would like to emphasize that such repetitions are intentional (being this a review article rather than an original article with novel findings. As such, one of the focuses of this review is to convey a “core” of specific issues on the topic.
